Sony Electronics Inc. (for U.S. sales) or Sony of Canada Ltd. (for Canadian sales) ("Sony") warrants this product against defects in material or workmanship for the original and any subsequent end user owner(s) ("Sou") for the time periods and as set forth below when purchased directly from Sony or a Sony Retailer. Under this Limited Warranty, Sony will, at its option, (i) repair the product using new or refurbished parts or (ii) replace the product with a new or refurbished product. "Refurbished" means a product or part that has been returned to its original specifications. These are your exclusive remedies. Sony does not warrant that the operation of the product will be uninterrupted or error-free.

Term of this Limited Warranty: For a period of one (1) year (ninety (90) days for labor) from the original date of purchase of the product (or ninety (90) days from original date of purchase for commercial use). This Limited Warranty is transferable. However, any transfer of this product does not extend the term. A copy of the dated receipt from Sony or a Sony Retailer or bill of sale from the original end user purchase is required to determine coverage. Online auction confirmations are not accepted for warranty verification.

Product Coverage: Only the hardware components packaged with the Product are covered. Technical assistance for hardware or software usage and any software products are not covered. Any software is provided "AS IS" unless expressly provided for in any enclosed software Limited Warranty. When a product or part is exchanged, any replaced tem becomes Sony's property. Any replacement product provided under this limited warranty may vary in the color and/or cosmetic design from the original product and may not include any original engraving or similar customization
